("Crown Castle") and CCGS Holdings LLC, in exchange for either 1.61 shares of Crown Castle common stock or \$55.95 in cash, at each stockholder's election and subject to proration as described in the Merger Agreement. Crown Castle will issue a press release announcing the final merger consideration when it is determined.
