ITEM 1. SECURITY AND ISSUER

Item 1 is amended to read:

The class of securities to which this statement relates is common stock, par value \$.0001 per share (the "Common Stock") of Athena Silver Corporation, a Delaware corporation (the Company). The address and principal executive offices of the Company is 2010A Harbison Drive #312, Vacaville, CA 95687.

ITEM 2. IDENTITY AND BACKGROUND

(a)-(c) John C. Power, 60 Sea Walk Drive, P O Box 114, Sea Ranch CA 95497 is Chief Executive Officer, Chief Financial Officer and a Director of the

Company and is Manager of Sea Ranch Lodge and Village, LLC; P O Box 114, Sea Ranch CA 95497.

(d)-(f) The natural person referred to above is a United States Citizen. During the last five years, he has not been (i) convicted in any criminal proceeding (excluding traffic violations or similar misdemeanors) or (ii) has been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws, except as follows:

ITEM 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION

Item 3 is amended as follows:

On September 14, 2010, Mr. Power purchased 10,000 shares of \$0.0001 par value common stock of the Company at a purchase price of \$0.094 per share.

On October 14, 2010, Mr. Power purchased 20,000 shares of \$0.0001 par value common stock of the Company at a purchase price of \$0.085 per share. The shares are titled in the name of John Power as custodian for Robert Henry Josiah Power, a minor.

On November 15, 2010, Mr. Power acquired 300,000 shares of \$0.001 par value common stock of the Company in satisfaction of debt owed him in the amount of \$30,000.

ITEM 4. PURPOSE OF TRANSACTION

Item 4 is amended as follows:

The securities of the Company were acquired by Mr. Power for investment. Mr. Power reserves the right to acquire additional shares of the Company's common stock, either in open market purchases should a public trading market for its shares develop or in private transactions.

ITEM 5. INTEREST IN SECURITIES OF THE ISSUER

Item 5 is amended as follows:

(a) At the close of business on November 15, 2010, Mr. Power would be deemed the beneficial owner, within the meaning of Rule 13d-3 under the Exchange Act, of an aggregate of 3,393,000 shares of common stock. Those securities consist of an aggregate of 3,373,000 shares of common stock owned individually. Additionally, there are 20,000 shares of common stock owned by John Power as custodian for Robert Henry Josiah

Power, a minor. Mr. Power disclaims any pecuniary interest in the shares held as custodian. The securities represent 12.64% of the issued and outstanding shares of common stock of the Company. The foregoing is based upon 26,845,000 shares of common stock issued and outstanding as of the date of this report.

(b) Mr. Power has the sole voting and dispositive power with respect to all of the shares of common stock identified in Item 5(a) above.

(c) Mr. Power has not purchased or sold any shares of common stock during the past 60 days except as noted.
