Item 1.04. Mine Safety.

On July 1, 2015, Premier Silica LLC ("Premier Silica"), a subsidiary of Pioneer Natural Resources Company (the "Company"), underwent a periodic inspection by the Mine Safety and Health Administration ("MSHA") at Premier Silica's Riverside operation in Riverside County, CA. In the course of that inspection, Premier Silica received an imminent danger order issued by MSHA under section 107(a) of the Federal Mine Safety and Health Act of 1977. According to the order, among other allegations, there was a detector monitoring the condition of possible ground faults within the plant that provides visual and audible indicators, and the audible indicator was not functioning properly. The defect was repaired and there was no accident or injury. Under the rules of the Securities and Exchange Commission, the Company is required to disclose the issuance of this order on Form 8-K.
