- (1) The common stock sold includes (i) 13,333 shares which were part of an original grant of 40,000 restricted shares, which became transferable in three equal annual installments commencing September 1, 2009; (ii) 16,667 shares which were part of an original grant of 50,000 restricted shares, which became transferable in three equal annual installments commencing November 10, 2011; and (iii) 183,334 shares which were part of an original grant of 275,000 restricted shares, which became transferable in three equal annual installments commencing February 8, 2013.
(2) Dr. Belamant owns 725,799 shares of common stock held by the CI Law Trustees Limited for the San Roque Trust dated 8/18/92. Dr. Belamant, as proxy of CI Law Trustees, has the power to vote all of the CI Law Trustees' shares.
