GMH Communities Trust (the Company) has experienced delays in finalizing its financial statements for the quarter ended June 30, 2006. These delays are due primarily to the delayed filing of the Company's financial statements for the year ended December 31, 2005 and the first quarter ended March 31, 2006, which were just recently completed over the prior several weeks. As a result of its focus on those financial statements, the Company has been unable to complete the financial statements relating to its second quarter ended June 30, 2006 by the requisite filing date. These delays could not have been eliminated without unreasonable effort or expense.
