KapStone Paper and Packaging Corporation has announced to its customers that, effective with March 13, 2017 shipments, the price of all North America containerboard products will increase by \$50 per ton, the price for all corrugated boxes will increase by 10 percent, and the price for all corrugated sheets will increase by 12 percent.
