**CBOE HOLDINGS, INC. TO JOIN S&P 500**

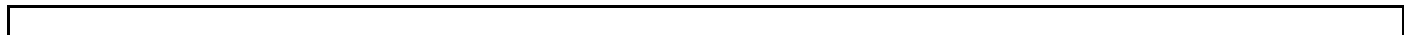
