These holdings have been trued up to conform to the RSP balance as of 01/04/2010, and reflect the acquisition of approximately 5.10 shares on 4/15/09, 6.14 shares on 7/15/09, and 6.34 shares on 10/15/09 due to dividend reinvestment.
