- (1) Original shares reported assumed shareholder elected to receive 100% stock in the elective dividend paid on December 11, 2009 under the Prospectus Supplement published November 5, 2009. Shares are changed to reflect actual shareholder election. Includes 607 shares of restricted stock awarded under the Cousins Properties Incorporated (CPI) 1999 Incentive Stock Plan. These shares will vest 25% per year on each anniversary date of the grant as previously disclosed, and CPI will hold these shares until such shares become vested. While the shares are being held prior to vesting, the reporting person will have the right to receive all cash dividends and to vote the restricted shares. All unvested shares will forfeit if the Director's service as a member of the CPI Board of Directors terminates, unless separation is due to death.
