- (1) Each restricted stock unit represents one share of CIT common stock.  
 RSU's are scheduled to vest in three equal installments on the first, second and third anniversaries of the date of grant and are payable
- (2) 50% in shares of CIT common stock and 50% in cash. The cash payment shall be based on the closing price of CIT common stock on the vesting date.
- (3) Deferred share units ("DSU") will expire and settle in shares of common stock upon filer's departure from the Board.
- (4) Each Deferred Share Unit is the economic equivalent of one share of CIT common stock.
- (5) Filer elected to defer issuance of stock until he is no longer a member of the Board.
- (6) Each restricted stock unit ("RSU") had the economic equivalent of one share of CIT common stock.
- (7) Filer elected to defer settlement of these RSU's as DSU's until he is no longer a member of the Board of CIT.
- (8) Filer elected to receive 100% stock upon settlement.
