On October 1, 2013, in accordance with the provisions of the Elizabeth Klein 2003 Trust Agreement, 3,750 shares of AMETEK
(1) Common Stock were transferred directly to Elizabeth Klein who is not living in the same household. As a result, the reporting person is no longer required to report transactions or holdings of shares owned by such trust.
(2) Distribution of shares by the trust in accordance with the terms of the trust. Mr. Klein disclaims beneficial ownership of all shares held by the trust.
This trust is a charitable remainder trust of which the reporting person and his spouse are two of the co-trustees and of which his wife is a beneficiary. The reporting person continues to report beneficial ownership of all of the AMETEK Common Stock held by the trust but disclaims beneficial ownership except to the extent of his wife's pecuniary interest therein.
(3) The stock options will become exercisable in four equal annual installments beginning on April 23, 2009.
