Mr. Lane invested an additional \$497,121.35 to acquire 23,500 shares of the issuer's common stock. This purchase is in addition to the \$3 million Mr. Lane invested in September 2008 to acquire 85,109 shares of the issuer's common stock. Collectively, Mr. Lane has invested (1) approximately \$3.5 million to acquire 108,609 shares of the issuer's common stock. Mr. Lane has also been awarded 175,113 shares of the issuer's restricted common stock, of which 49,548 shares have been surrendered to satisfy tax withholding obligations. Mr. Lane currently holds all of his ownership in the issuer through a limited partnership.
