Releasing Division Further Validates Company's Mission to Become Leading, Fully Integrated Entertainment Company

(AMEX:[PAE - News](#)) (TSX: [PAE.TO - News](#)), an innovative film and television entertainment company, today announced the launch of the Company's new U.S. theatrical distribution division, Peace Arch Releasing. The division's first release will be the feature film *Delirious*, which opens on August 8 in New York City. Peace Arch's President of U.S. distribution Mark Balsam will head the new division.

The launch of the new division is consistent with the Company's stated mission to become a leading, fully integrated entertainment company.

Delirious is the award-winning Tom DiCillo comedy starring Steve Buscemi, Michael Pitt, Alison Lohman, Gina Gershon and Elvis Costello. The picture, which had its North American premiere at the prestigious Sundance Film Festival in January, won the Best Director Award at both the San Sebastian Film Festival and the HBO U.S. Comedy Arts Festival, as well as Best Screenplay at San Sebastian. *Delirious* was the prestigious Centerpiece Film selection at the recent San Francisco Film Festival, and it will also screen at Seattle, Karlovy Vary, Sundance Institute/Brooklyn Academy of Music, Munich and Flanders during June and July.

Given our robust slate of new feature film and television productions, our recent purchase of one of the largest independent feature film libraries in the world and our pending acquisition of leading U.S. DVD distributor Trinity Home Entertainment, adding a U.S. theatrical releasing component is the next step in establishing Peace Arch as one of a very few independent, vertically integrated production, financing and distribution companies in North America, said Mr. Balsam. Peace Arch Entertainment's expanding line up of feature films and long-form television programming includes the powerful ensemble drama *Winged Creatures*, starring Kate Beckinsale, Forest Whitaker, Jennifer Hudson, Dakota Fanning, Guy Pearce and Jackie Earle Haley, and the film satire *The Deal* from the best-selling Peter Lefcourt novel, with a cast that includes William H. Macy, Meg Ryan, LL Cool J and Elliott Gould, which recently completed principal photography in South Africa; as well as the hit ten-part television event mini-series *The Tudors* starring Golden Globe® Award-winning actor Jonathan Rhys Meyers, which premiered to record audiences on Showtime in the US in April.
