connection with the Merger, all shares of the Issuer's common stock, par value \$0.001 per share ("Common Stock"), held by the Reporting Persons at the effective time of the Merger were exchanged for merger consideration consisting of \$12.00 in cash per share of Common Stock, subject to applicable tax withholding amounts, as described in the Merger Agreement.
