This Statement on Schedule 13G/A (this "Restated Filing") with respect to the Auction Rate Preferred shares (the "Shares") amends and restates in its entirety the Statement on Schedule 13G/A filed by the reporting persons on February 4, 2011 (the "Original Filing") with respect to the Shares. The Original Filing erroneously reported the percentage of the Shares beneficially owned by the reporting persons and erroneously indicated that the reporting persons had ceased to be the beneficial owners of more than 5 percent of the Shares. The information set forth in the body of this Restated Filing is as of December 31, 2010. The reporting persons remained the beneficial owners of more than 5 percent of the Shares on December 31, 2011, on which date the reporting person had sole voting power over 0 Shares, shared voting power over 587 Shares, sole dispositive power over 0 Shares, shared dispositive power over 587 Shares and beneficially owned 587 Shares in aggregate, representing 6.9% of the Shares outstanding (assuming 8,450 Shares outstanding, as reported in the issuer's Quarterly Schedule of Portfolio Holdings of Registered Management Investment Company on Form N-Q, filed on January 27, 2012).
