The first and second tranches each consist of 25% of the grant and the third tranche will consist of 50% of the grant. The first, second and third tranches vested on March 4, 2011, March 4, 2012 and March 4, 2013, respectively.
- (2) Includes 10,906 shares acquired through Employee Stock Purchase Plan and 8,237 unvested Restricted Stock Units.
