- (1) On January 2, 2014, the Issuer entered into an agreement with John T. Hayes (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 8,500 shares of Class A Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").

On January 2, 2014, restrictions applicable to a previously reported grant of 6,000 shares of Class A Common Stock lapsed, resulting in the Reporting Person becoming fully vested in such shares.
