The Restricted Stock Units (RSUs) will be settled solely with Issuer Common Stock upon an annual vesting schedule as provided for in the Award Agreement for the RSUs as follows: 34% not later than November 15, 2018, 33% not later than November 15, 2019, and 33% not later than November 15, 2020.
- (2) Acquisition of additional vested Market Share Units (Common Stock equivalents) upon certified performance vesting of Market Share Units (MSUs) awarded to the reporting person on October 13, 2014. Vested MSUs will be settled solely with Issuer Common Stock not later than November 15, 2017.
- (3) Total includes 5,613 RSUs, of which 1,642 are subject to future vesting, 571 MSUs (target number) awarded to the reporting person in 2015, all of which are subject to future vesting, 1,612 vested MSUs, and 280 vested Deferred Performance Units (Common Stock equivalents).
