(1) Represents the sale of 17,500 shares in 51 separate transactions ranging from \$76.50 to \$76.97 per share, resulting in a weighted average sale price per share of \$76.6533. The Reporting Person undertakes to provide upon request by the SEC staff, the Issuer, or a security holder of the Issuer, full information regarding the number of shares sold at each separate price within the range.

(2) Represents shares held in a GRAT of which the Reporting Person's spouse is a trustee. The Reporting Person disclaims beneficial ownership of such shares, except to the extent of his pecuniary interest therein.

(3) Represents options to purchase the Issuer's Class A Common Stock, \$0.001 par value (the "Common Stock").

An option to purchase 150,000 shares of the Issuer's Common Stock was issued to the Reporting Person under the Issuer's 2005 Omnibus Equity Plan. 37,500 shares of Common Stock became exercisable on each of October 16, 2009, October 16, 2010, and October 16, 2011, and an additional 37,500 shares of Common Stock will become exercisable on October 16, 2012.
