- (1) Each vested Restricted Stock Unit ("RSU") was converted into one share of common stock, par value \$0.01, of the Issuer (the "Common Stock") without additional payment (other than such conversion and reduction in the number of RSUs held) pursuant to the terms of the Restricted Stock Unit Award Agreement, dated December 10, 2014, between the Issuer and the Reporting Person (the "RSU Award Agreement").

The value of the Consideration on the date of issue was \$86,250. No additional consideration was received by the Issuer as payment for the RSUs.
