Item 7.01 Regulation FD Disclosure.

On March 17, 2016, Elite Pharmaceuticals, Inc. ("Elite" or the "Company") issued a press release announcing that its new drug application, or NDA, for SequestOx™, its investigational lead opioid abuse-deterrent drug candidate for the management of moderate to severe pain where the use of an opioid analgesic is appropriate, has been accepted and granted priority review by the U.S. Food and Drug Administration, or the FDA. A copy of the press release is furnished as Exhibit 99.1 to this Current Report on Form 8-K. As described above, on March 17, 2016, Elite announced that its NDA for SequestOx™ has been accepted and granted priority review by the FDA. In addition, the FDA has set a target action date under the Prescription Drug User Fee Act of July 14, 2016.
