Copart, Inc.'s Annual Meeting of Stockholders will be held on December 3, 2014 at 14185 Dallas Parkway, Suite 300, Dallas, TX 75254, at 8:00 a.m. Central Time.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommends a vote FOR all the nominees listed in Proposal 1 and FOR Proposals 2, 3 and 4:

1. Election of Directors: Willis J. Johnson, A. Jayson Adair, Matt Blunt, Steven D. Cohan, Daniel J. Englander, James E. Meeks, Vincent W. Mitz and Thomas N. Tryforos.
2. To approve the Copart, Inc. 2014 Employee Stock Purchase Plan.
3. Advisory (non-binding) vote to approve executive compensation for the year ended July 31, 2014 (say-on-pay vote).
4. To ratify the appointment of Ernst & Young LLP as our independent registered public accounting firm for the fiscal year ending July 31, 2015.
