## EXPLANATORY NOTE

On November 6, 2018, Cimarex Energy Co. (“Cimarex”) issued a press release concerning its financial results for the quarter ended September 30, 2018. The press release included a table entitled “Wells Brought on Production By Region”, which understated the total number of wells brought on production during the three months ended September 30, 2018. This table also was included on page 38 of the Quarterly Report on Form 10-Q for the quarter ended September 30, 2018 filed by Cimarex on November 6, 2018. While Cimarex does not believe the correction of the well count is material and does not intend to amend its Quarterly Report on Form 10-Q for the quarter ended September 30, 2018, Cimarex issued a corrected press release on November 6, 2018 showing the correct number of wells brought on production during the quarter in the table and other well references. The corrected press release is filed as Exhibit 99.1 to this amended Current Report on Form 8-K.
