On November 15, 2005, the Board of Directors of The First of Long Island Corporation amended Article III, Sections 6 of the Corporation s bylaws entitled Regular Meeting and eliminated Article III, Section 14 of the bylaws entitled Retirement. Article III, Section 6 of the bylaws was amended to provide for regular meetings of the Board of Directors on the third Tuesday of every month, with the exception of August, rather than the third Tuesday of each January, April, July and October.
