Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.

On December 22, 2015, Todd M. Ricketts, who joined the Board of Directors of TD Ameritrade Holding Corporation effective January 1, 2015 as the designee of the Ricketts parties under TD Ameritrade's stockholders agreement, dated June 22, 2005, as amended ("Stockholders Agreement"), was elected to remain on the board as an independent director, effective February 18, 2016. The Ricketts shareholders will cease to be parties to the Stockholders Agreement on January 24, 2016, which then requires Mr. Ricketts to resign as a director the day prior to the next annual stockholders meeting.

On December 22, 2015, Irene R. Miller, a designee of The Toronto-Dominion Bank, was elected to the board of directors as a Class II director under the terms of the Stockholders Agreement, effective immediately, and V. Ann Hailey was elected to the board of directors as a Class III and independent director, effective January 1, 2016. Each of Mr. Ricketts and Mses. Miller and Hailey will be entitled to receive compensation under the terms of the TD Ameritrade Holding Corporation 2006 Directors Incentive Plan (which is described in TD Ameritrade's proxy statement filed with the SEC on January 2, 2015 and incorporated herein), and each of Ms. Hailey and Ms. Miller will enter into an Indemnification Agreement with TD Ameritrade described in Item 1.01 of the current report on Form 8-K filed with the SEC on November 26, 2014.
