These derivative securities are currently redeemable, except that 19 Units are redeemable beginning 9/15/2011. The Units have no expiration date.
- (1) The reporting person's spouse made a gift of Units to a 2011 GRAT for the benefit of the reporting person's spouse. The reporting person is the trustee of this GRAT.
