- (2) These are Long Term Incentive Plan Deferred Stock Units granted 2/29/2008, and governed under the 2007 Stock Incentive Plan. Units are granted at a rate of \$1.00 for each dollar of bonus earned. The units accrue interest quarterly in the form of Deferred Stock Units and are to be settled in 100% Tennant Common Stock upon termination of employment. The units themselves vest at the time of the grant. The original Form 4 inadvertently omitted this grant of units.
