(1) The recipient receives a cash payment for each unit equal to the fair market value on the vesting date of one share of the Company's common stock. Of the original award of phantom stock units, 14,145 units vested on February 6, 2015. The remaining 14,145 phantom stock units will vest on February 6, 2016. This amendment is filed to correct the date in Table I, Column 3.

(2) Includes 365,212 shares owned by a residuary trust for the benefit of Peter D. Carlino and Peter D. Carlino's children. The reporting person is a trustee of the residuary trust with shared voting and investment power.
