I am making shares of stock held by my limited liability company through Zions as follows: 2,000 shares each month with 1,000 shares sold on the 7th trading day after the end of each month and 1,000 shares sold on the 7th trading day before the end of the month. All sales are subject to a per share price of \$33.75. The first sales will occur on February 6th and February 10th respectively. This plan supercedes and cancels all prior plans that I have communicated.
