(3) 123,877 dividend equivalent rights being reported reflect 40,1289 dividend equivalent rights at \$25.18 per RSU credited to the reporting person's account on 07/03/13; 47,2171 dividend equivalent rights at \$21.40 per RSU credited to the reporting person's account on 10/02/13; and 36,5310 dividend equivalent rights at \$27.66 per RSU credited to the reporting person's account on 01/02/14.
