The restrictions lapse on one quarter of the shares semi-annually during the two-year restriction period, so long as Mr. Dinwoodie remains employed by SunPower. 263,910 shares remain to vest on 1/10/2008, 263,911 shares on 7/10/2008 and 263,911 on 1/10/2009.
