- (1) Shareholders. If a director is appointed on a date other than the Annual Meeting date, he/she receives a pro-rata portion of the \$80,000 grant. Ms. Heisz was appointed on November 17, 2010 and received as a pro-rated amount, \$41,424.657 in HCC shares. Therefore, at the closing price of \$27.94, she received 1,482 shares.
