Of the 110,438 shares of common stock shown in Table I, Box 5, Mr. Pfeiffer's ex-wife is entitled to 15,794 restricted shares of common stock, which will be transferred to his ex-wife upon vesting pursuant to the DRO, and over which he disclaims any beneficial ownership or pecuniary interest.
