- (1) On May 5, 2008, the reporting person received a grant of restricted stock units ("RSUs") covering 8,000 shares of KLA-Tencor common stock. On May 5, 2012, the reporting person vested in the remaining fifty-percent (50%) of such RSUs.
- (2) Pursuant to the terms of the May 5, 2008 RSU grant, 1,468 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding. Because the vesting date of such RSUs occurred on a day on which the NASDAQ Stock Market was closed for trading, the fair market value of KLA-Tencor common stock used for purposes of calculating the number of shares to be

withheld was the closing price of KLA-Tencor common stock as reported on the NASDAQ Stock Market on the last completed trading day immediately prior to such vesting date.

(3) This transaction was effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on December 12, 2011.

(4) Each RSU represents a contingent right to receive one share of KLA-Tencor common stock.
