 - (1) Includes 5,095 restricted stock units (RSUs) mandatorily deferred by the Company from Mr. Stadler's discretionary bonus, plus 1,273 RSUs granted to Mr. Stadler as a company match on his mandatory bonus deferral. These RSUs generally vest on the third anniversary of grant. Also includes 8,493 RSUs voluntarily deferred by Mr. Stadler from his discretionary bonus, plus 2,123 RSUs granted to Mr. Stadler as a company match on his voluntary bonus deferral. These RSUs generally will be delivered on the third anniversary of grant. Also includes 9,706 RSUs that vest one-fifth ratably on each of January 27, 2007, 2008, 2009, 2010 and 2011. All of these RSUs were granted pursuant to the Company's 2004 Stock Incentive Plan.
