Item 1.01 Entry Into a Material Definitive Agreement

On November 19, 2013, the Registrant and Ruby Development Company ("RDC") executed an Amendment (the "Amendment") to the Modification and Extension Agreement (the "Modification Agreement") dated March 19, 2013 to the Secured Promissory Note (the "Note", or the "mortgage") with RDC dated July 1, 2011.

The Amendment replaces the \$1,000,000 payment that was due on December 30, 2013 with additional monthly installment payments paid over the term of the Note, such that it will now be paid in full on or before December 30, 2015. Together with the current mortgage payment of \$20,000 per month, aggregate monthly mortgage payments including said additional installments shall then be a minimum of \$60,000 per month, beginning January 1, 2014. The Registrant retains the option to accelerate payment of principal at any time, and at no penalty.

As consideration for this Amendment, the Registrant has agreed to issue 4,000,000 warrants to RDC at an exercise price of \$0.04, expiring on December 30, 2018. The Registrant has also agreed to extend the expiration date of the 14,000,000 outstanding and unexercised warrants currently held by RDC until December 30, 2018. In addition, the Registrant has agreed to reimburse RDC for legal fees incurred during the negotiation on the terms of said Amendment.

All other terms and conditions of the original Note and Modification Agreement, as amended, shall remain in effect.
