The shares in ArvinMeritor common stock funds are held in an employee benefit trust fund established under the Plan.
- (2) Pursuant to agreement with the issuer, delivery of common stock is deferred until satisfaction of certain conditions.
- (3) Periodic acquisitions of additional shares through automatic reinvestment of dividends. Information provided by dividend reinvestment plan administrator as of October 31, 2002.
- (4) Held by the issuer to implement restrictions on transfer unless and until certain conditions are met.
- (5) Periodic acquisitions of share equivalents related to ArvinMeritor common stock, held under ArvinMeritor's supplemental savings plan, based on information furnished by the Plan Administrator as of October 31, 2002.
- (6) Options will become exercisable in whole or in part (but only for a whole number of shares) as to one-third of the option shares beginning on November 22, 2003, as to an additional one-third of the option shares beginning on November 22, 2004, and as to the balance of the option shares beginning on November 22, 2005.
