Unilever NV also announces that 47,301 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 77,422,235 Unilever NV ordinary shares in treasury, and has 1,637,305,465 Unilever NV ordinary shares in issue (excluding treasury shares).
