Unilever NV announces that on 26 November 2007 it purchased 250,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 23.700 and euro 24.090 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 27,259 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, hold 115,655,876 Unilever NV ordinary shares in treasury and has 1,599,071,824 ordinary NV shares in circulation.
