(the Company ) adopted technical amendments to the Company s Amended and Restated By-Laws to expressly authorize the issuance of uncertificated shares of capital stock. The Board of Directors adopted these amendments to comply with the New York Stock Exchange (the NYSE ) requirement that securities listed on the NYSE be eligible for participation in the Direct Registration System by January 2008.
