On June 23, 2013, (i) sTec, Inc. ("sTec") entered into an Agreement and Plan of Merger (the "Merger Agreement") with Western Digital Corporation, a Delaware corporation ("Parent") and Lodi Ventures, Inc., a California corporation and a wholly-owned subsidiary of Parent ("Merger Sub"), and (ii) Mark Moshayedi, in his personal capacity, and Mark Moshayedi and Semira Moshayedi, each in their capacity as co-trustees of the M. and S. Moshayedi Revocable Trust, dated 9/25/98, entered into a Voting Agreement (the "Voting Agreement") with Parent. Pursuant to the Voting Agreement, Mark Moshayedi and the M. and S. Moshayedi Revocable Trust, dated 9/25/98 agreed, among other things, to vote their shares of sTec common stock for the adoption and approval of the Merger Agreement and against any alternative proposal and against any action or agreement in opposition of the transactions contemplated by the Merger Agreement. Pursuant to the Voting Agreement, Mark Moshayedi and the M. and S. Moshayedi Revocable Trust, dated 9/25/98 granted an irrevocable proxy to Parent's designees to vote as set

forth above with respect to such matters, but retained the right to vote their shares of common stock on such matters so long as the vote is in accordance with the Voting Agreement.

As a result of the Voting Agreement, Mark Moshayedi, Semira Moshayedi and the M. and S. Moshayedi Revocable Trust, dated 9/25/98, may be deemed to share with Parent the power to vote or direct the vote of the common stock. However, Parent is not entitled to any rights as a stockholder of sTec under the agreement.

The foregoing description of the Merger Agreement and the Voting Agreement does not purport to be complete and is qualified in its entirety by reference to the Merger Agreement and the form of Voting Agreement, copies of which are filed as Exhibits 2.1 and 99.1, respectively, to sTec's current report on Form 8-K filed with the Securities and Exchange Commission on June 25, 2013.

The filing of this Schedule 13G/A shall not be construed as an admission that Mark Moshayedi is, for purposes of Section 13(d) or 13(g) of the Act, the beneficial owner of such shares.

Semira Moshayedi disclaims beneficial ownership, except to the extent of her pecuniary interest therein, if any, of the shares held by the M. and S. Moshayedi Revocable Trust and her spouse. The filing of this Schedule 13G/A shall not be construed as an admission that Semira Moshayedi is, for purposes of Section 13(d) or 13(g) of the Act, the beneficial owner of such shares.
 - (5) As a result of the Voting Agreement entered into in connection with the Merger Agreement, Mark Moshayedi and the M. and S. Moshayedi Revocable Trust, dated 9/25/98, may be deemed to share with Parent the power to vote or direct the vote of the common stock pursuant to the terms of the Voting Agreement. However, Mark Moshayedi and the M. and S. Moshayedi Revocable Trust, dated 9/25/98 retain the right to vote their shares of common stock with respect to matters not covered by the Voting Agreement.
