On December 11, 2013, Global Ship Lease, Inc. (the Company) issued a press release announcing that the Company intends to offer an aggregate principal amount of up to \$400.0 million first priority secured notes due 2021 (the Notes) in a private placement (the Offering). This announcement does not constitute an offer to sell or the solicitation of an offer to buy Notes in any jurisdiction in which such an offer or sale would be unlawful.
