DEREGISTRATION OF UNSOLD SECURITIES

This Post-Effective Amendment relates to the Registration Statement on Form S-4 (No. 333-62317) (the <u>Registration</u> <u>Statement</u>) filed by Consolidated Graphics, Inc., a Texas corporation (<u>Consolidated Graphics</u>) with the Securities and Exchange Commission on August 26, 1998, as amended by Amendment No. 1, filed on August 31, 1998, which registered the offering of an aggregate of 2,000,000 shares of common stock of Consolidated Graphics, \$0.01 par value per share.

Consolidated Graphics entered into an Agreement and Plan of Merger (the <u>Merger Agreement</u>), dated as of October 23, 2013, by and among Consolidated Graphics, R.R. Donnelley & Sons Company, a Delaware corporation (<u>R.R. Donnelley</u>), and Hunter Merger Sub, Inc. a Delaware corporation and a wholly owned subsidiary of R.R. Donnelley (<u>Merger Sub</u>), pursuant to which Merger Sub merged with and into Consolidated Graphics (the <u>Merger</u>), with Consolidated Graphics surviving the Merger as a wholly owned subsidiary of R.R. Donnelley upon the terms and subject to the conditions set forth in the Merger Agreement.

The Merger became effective on January 31, 2014.

In connection with the Merger, the offering pursuant to the Registration Statement has been terminated. Consolidated Graphics hereby removes from registration the securities registered under the Registration Statement that remain unsold as of the filing date of this Post-Effective Amendment.
