On September 30, 2014, HC2 Holdings, Inc. (the Company) issued a press release announcing that it has extended the expiration time of its previously announced tender offer for all of the outstanding shares of common stock of Schuff International, Inc. (Schuff) that it does not already own to October 6, 2014 at 5:00 PM, New York City Time, unless further extended. The press release also announced that HC2 had waived the 90% Condition to the offer and reported updated information previously announced by Schuff.
