- (iii) Och-Ziff Capital Management Group LLC ( OZM ), a Delaware limited liability company, is a holding company that is the sole shareholder of OZHC.
- (iv) Daniel S. Och is the Chief Executive Officer of OZHC and the Chief Executive Officer, an Executive Managing Director and Chairman of OZM.

The citizenship of each of OZ, OZHC, and OZM is set forth above. Daniel S. Och is a United States citizen.

OZ and OZ Management II LP ( OZII ) each serve as the principal investment manager to the Accounts. OZII is a wholly-owned subsidiary of OZ and, as such, OZ may be deemed to be the beneficial owner of Class A Common Stock, par value \$.01 per share ( Common Stock ) held in the Accounts managed by OZII. OZ is the sole member of Och-Ziff Holding II LLC ( OZHII ), the general partner of OZII. As a result, OZ has voting and dispositive authority over the Common Stock reported in this Schedule 13G. OZHC serves as the sole general partner of OZ. As such, OZHC may be deemed to control OZ and therefore may be deemed to be the beneficial owner of the Common Stock reported in this Schedule 13G. OZM is the sole shareholder of OZHC, and for purposes of this Schedule 13G may be deemed to be the beneficial owner of the Common Stock reported in this Schedule 13G. Mr. Daniel S. Och is the Chief Executive Officer and an Executive Managing Director of OZM. As such, for purposes of this Schedule 13G, he may be deemed to control such entity and, therefore, be deemed to be the beneficial owner of the Common Stock reported in this Schedule 13G.

The percentages used in this Item 4 are calculated based on 51,725,074 shares of Common Stock outstanding as of May 1, 2015, as reported in the Issuer's Form 10-Q filed on May 14, 2015. Beneficial ownership information is presented as of June 18, 2015.
