This option was previously reported as covering 2,000 shares at an exercise price of \$32.50 per share, but was adjusted to reflect the stock split on May 25, 2005.

(3) Part of a grant to the reporting person of 10,000 shares from the Issuer's 2000 Stock Plan. The options vested in five equal annual installments beginning 02/07/2003. This option was previously reported as covering 5,000 shares at an exercise price of \$33.73 per share, but was adjusted to reflect the stock split on May 25, 2005.

(4) Part of a grant to the reporting person of 10,000 shares from the Issuer's 2000 Stock Plan. The options vested in five equal annual installments beginning 02/11/2005. This option was previously reported as covering 5,000 shares at an exercise price of \$48.98 per share, but was adjusted to reflect the stock split on May 25, 2005.
