These are deferred stock units acquired pursuant to the deferred stock arrangements for non-employee directors in accordance with the terms of the Company's 2004 Omnibus Incentive Plan ("Omnibus Plan"). The deferred stock units are converted into shares of Company

(1) Class A Common Stock on a one-for-one basis upon distribution. Distribution of shares of Class A Common Stock occurs the first day of the calendar month after a director's service on the Board terminates or upon another date or dates designated by the director pursuant to the Omnibus Plan.

(2) Includes: (1) the 3553.24 shares of deferred stock units previously granted pursuant to the Company's Omnibus Plan, (2) 2000 shares of Class A Common Stock and (3) 436.16 shares of deferred stock units being reported.

(3) These shares are held by an HR-10 Plan for the benefit of Mr. Anestis.
