Under this plan, fees are converted quarterly into phantom shares at the fair market value of the company's Class A Common shares on the last trading day of each quarter. Upon retirement as a director, the balance may be paid in either shares or cash. The balance at 3/30/07 was 5,924.42 phantom shares.
- (2) The exercise price of this nonqualified stock option award granted under the company's 1997 Long-Term Incentive Plan is \$43.28.
