- (1) Mr. Shaw previously incorrectly reported that 893 common units of the Issuer were surrendered to satisfy his tax liability incident to the vesting of restricted units. The number of common units surrendered was actually 727, which is 166 common units less than the number that was incorrectly reported on the Form 4 filed by Mr. Shaw on January 5, 2010. As a result of this reporting error, the Form 4 filed by Mr. Shaw on March 3, 2010 understated by 166 common units the total number of common units held by Mr. Shaw.
