- (1) These securities are restricted stock units. Each unit represents the reporting persons right to receive one share of common stock. These restricted stock units shall vest at the rate of 1/4 of the shares subject to such restricted stock units as of the first anniversary of the vesting commencement date and 1/4 of the shares subject to such restricted stock units as of each of the subsequent anniversaries of the vesting commencement date thereafter, assuming continued service with the company on each vesting date. For the purposes of the restricted stock unit grant the vesting commencement date is February 1, 2015.
- (2) Certain of these securities are restricted stock units. Each unit represents the reporting person's right to receive one share of common stock, subject to the applicable vesting schedule.
- (3) These options are exercisable at the rate of 1/48th of the shares subject to such options on each monthly anniversary of the vesting commencement date, assuming continued service with the company on each vesting date. Such options have a term of seven years from the date of grant. For purposes of the option grant the vesting commencement date is February 1, 2015.
